Confirming that I spoke with § 22 last night as scheduled at just after 6:30.

§ 47C, § 47E(d)

§ 22 noted that this issue had now been around for some time and since the December attacks raised in prominence and that timely steps were important. I confirmed that ASIC was very much acting quickly and indeed had been forward leaning in identifying options and engaging with stakeholders such as the AICD. I noted that ASIC very much understood priority and heightened risk and therefore importance of timely consideration but that it was also important to understand implications of actions and test assertions as to absence of use cases likely to be impacted. I also noted that the Government, through Treasury had been progressing more substantive solutions through a timely consultation process and this was relevant background to steps government has been taking.

I noted that we had teams working on it overnight and would test capacity to progress ahead of timeframe we had set out. I advised I could update her on Thursday morning. § 22 noted that she was contactable until 4:00pm and was pleased to await a substantive update if that assisted.

Overall § 22 seemed appreciative of the call and engaged with the nuances to be navigated.
