

#### **ASIC Annual Forum 2024 Privacy Collection Notice**

Huddle Agency Pty Ltd (**Huddle**) ACN 645 691 327, on behalf of the Australian Securities and Investments Commission (**ASIC**), collects personal information about you to register you for the ASIC Annual Forum 2024 (**Event**) and for other purposes related to the Event.

### Information we collect

We will collect your name, contact details, gender, organisation, position, emergency contact details, dietary and accessibility requirements.

## Purpose for collection

We will collect, use, and disclose your information to:

- record and manage your registration and attendance at the Event for example to arrange payment, accommodation, safety, security and accessibility for you at the Event;
- assist us in the administration of the Event including collating a list of attendees to circulate (as necessary) to other attendees, presenters, and our Event partners to deliver the Event;
- allow you to participate in activities of the Event;
- invite you to future ASIC Annual Forums and other stakeholder engagement events that we host; and
- compile and analyse statistics and feedback about the Event.

### How we collect information

We collect personal information from you or your authorised representative on the web platform, Cvent.

When registering for the Event you may elect your privacy preferences and visibility to other attendees on the attendee list.

## Your consent to collection

If you are in a country that is a member of the European Economic Area, your consent under the <u>EU General Data Protection Regulation</u> 2016/679 is essential so we can collect and process your personal data for the above purposes.
