### **OTHER MATTERS:**

- A. The Court notes that on 11 September 2024 the plaintiff and the first to fourth, and, sixth to eighth defendants, filed an agreed statement of facts.
- B. On 5 June 2024, the fifth defendant was placed into liquidation, and the proceedings are stayed as against it.

## THE COURT ORDERS THAT:

## Agreed proposed form of relief

1. On or before 20 September 2024, the plaintiff and the first to fourth, and, sixth to eighth defendants file an agreed form of proposed declarations and orders in respect of final relief.



#### **Further evidence**

- 2. On or before 30 September 2024, the plaintiff provide the first to fourth, and, sixth to eighth defendants with a draft further statement of agreed facts in respect of the relief to be sought at the final hearing.
- 3. On or before 7 October 2024, the first to fourth, and, sixth to eighth defendants provide the plaintiff with any comment and suggested changes to the draft further statement of agreed facts.
- 4. On or before 14 October 2024:
  - (a) the plaintiff, after conferral and agreement with the first to fourth, and, sixth to eighth defendants, file any further statement of agreed facts; and
  - (b) the parties file any evidence, and identify with precision any evidence that has already been filed, on which they intend to rely at the final hearing.

## **Submissions**

- 5. On or before 28 October 2024, the parties file any agreed submissions on which they intend to rely at the final hearing.
- 6. If the parties do not file any agreed submissions in accordance with order 5:
  - (a) on or before 4 November 2024:
    - (i) the plaintiff file and serve any submissions on which it intends to rely at the final hearing; and
    - (ii) the plaintiff provide the first to fourth, and, sixth to eighth defendants with a list of authorities upon which it intends to rely at the final hearing;
  - (b) on or before 18 November 2024:
    - (i) the first to fourth, and, sixth to eighth defendants file and serve any submissions on which they intend to rely at the final hearing; and



- (ii) the first to fourth, and, sixth to eighth defendants provide the plaintiff with a list of authorities upon which they intend to rely at the final hearing;
- (c) on or before 25 November 2024, the plaintiff file and serve any written outline of submissions in reply.

# Final hearing date

7. The proceeding be fixed for final hearing at 10.15 am on 27 November 2024 for an estimate of one day.
