#### 1. Name

This is the Australian Market Licence (Choe SEF, LLC) 2023.

#### 2. Commencement

This Licence commences when it is granted.

#### 3. Definitions

Act means the Corporations Act 2001.

ASIC means the Australian Securities and Investments Commission.

Australian client means, in relation to a participant in the Market, a person in this jurisdiction on whose behalf the participant deals on the Market.

#### Grant of Licence
