Guide: Notice of application to court to manage corporation

This guide does not form part of the prescribed form and is included by ASIC to assist you in completing and lodging form 318.

Signature	This form must be signed by the person who has been disqualified by the court from managing corporations,
Lodging period	21 days before making application to the Court. Generally, a form is not regarded as being lodged until it is received and accepted by ASIC as being in compliance with s1274(8) of the Corporations Act 2001.
Lodgement fee	Nil.
Other forms to be completed	Nil.
Additional information	<p>Under section 206G(1) of the Corporations Act 2001 a person who has been disqualified by the Court from managing corporations may apply to the court for leave to manage:</p> <ul style="list-style-type: none">(a) corporations; or(b) a particular class of corporation; or(c) a particular corporation.
How to provide additional information	<p>Annexures</p> <p>If there is insufficient space in any section of the form, you may submit annexures as part of this lodgement.</p> <p>To make any annexure conform to the regulations, you must</p> <ol style="list-style-type: none">1. use A4 size paper of white or light pastel colour with the margin of at least 10mm on all sides2. show the corporation name and ACN3. number the pages consecutively4. print or type in BLOCK letters in dark blue or black ink so that the document is clearly legible when photocopied5. identify the annexure with a mark such as A, B, C, etc6. endorse the annexure with the words: This is annexure (mark) of (number) pages referred to in form (form number and title)7. sign and date the annexure <p>The annexure must be signed by the same person(s) who signed the form</p>
